 In addition to the COVID-19 pandemic response, the PECC is working closely with Water Stewardship, the BC Wildfire Service, and other key stakeholders in preparing for and responding to freshet flooding and wildfire events across the province

On 2020May20, the Province issued the following announcement:

- Government has issued two emergency orders that temporarily suspend in-person execution requirements for wills
  and personal planning instruments, including representation agreements and enduring powers of attorney. The
  emergency orders address concerns raised by the legal community, including the regulatory bodies and
  representative associations for lawyers and notaries public, as well as by members of the public, regarding the
  requirement that such legal documents be executed and witnessed in person (information bulletin available <a href="here">here</a>)
   On 2020May19, the Province issued the following announcement:
- The Province announced temporary pandemic pay to support people working on the front lines in B.C.'s health-care system, social services and corrections. This includes workers delivering a range of health and social services to people most vulnerable to COVID-19. More than 250,000 eligible front-line workers will receive temporary pandemic

people most vulnerable to COVID-19. More than 250,000 eligible front-line workers will receive temporary pandemic pay, a lump-sum payment of about \$4 per hour for a 16-week period, starting on March 15, 2020. Eligible workers will receive the payment directly through their employer and do not need to apply (news release available here)

# Orders issued under the Emergency Program Act:

- Relocation of persons in homeless encampments
- Suspending bylaws that restrict goods delivery at any time of day
- Banning the secondary resale of food, medical supplies, personal protective equipment, cleaning and other essential supplies, and restricting quantities of items purchased at point of sale
- Enabling municipal bylaw officers to support enforcement of the Provincial Health Officer's orders for business closures and gatherings, in line with offences under the Public Health Act
- Ensuring all passenger and car-ferry services provide minimum service levels and priority access for residents, and essential goods and workers
- Suspending local states of emergency specific to the COVID-19 pandemic, except for the City of Vancouver
- Suspend limitation periods to commence court proceedings in British Columbia and provide statutory decisionmakers with discretion to waive, suspend or extend time periods related to their powers for the duration of the Provincial State of Emergency

#### **Federal announcements:**

On 2020May21, the Government of Canada issued the following announcements:

- The Prime Minister announced \$75 million in new funding for Indigenous organizations providing services to Indigenous peoples in urban centres and off reserve. This additional funding will support more community-based projects that address the critical needs of Indigenous populations during this crisis, including food security, mental health support services, and sanitation and protective equipment. It could also help with other needs, such as support for Elders, transportation, and educational materials for Indigenous children and youth. Funding for projects will start rolling out in the coming weeks (news release available <a href="here">here</a>)
- Minister of Labour issued a statement on ongoing engagement with provincial and territorial counterparts and leaders of labour and industry to keep Canadian workers safe (full statement available <a href="here">here</a>)

On 2020May20, the Government of Canada issued the following announcements:

- The Prime Minister announced that application documents and updated criteria for Canada Emergency Commercial Rent Assistance (CECRA) for small businesses are now available, and that the program will be opened for applications beginning on 2020May25 (news release available <a href="https://example.com/here">here</a>)
- Government of Canada shared legislative proposals to address issues relating to legislative time limits and deadlines.

# **Health Emergency Coordinating Centre (HECC) Overview:**

- The province has established a health system emergency structure led by the Provincial Health Officer, Dr Bonnie Henry and Deputy Minister of Health Stephen Brown, and is supported by the Emergency Management Unit and other key program areas within the Ministry of Health (MoH), Health Emergency Management BC (HEMBC) and the BC Centre for Disease Control (BCCDC)
- HEMBC coordination calls will decrease in frequency to once every two weeks starting the week of 2020May25
- Non-urgent scheduled surgeries resumed 2020May18

- As of 2020May20, there is one new long-term care or assisted-living facility outbreak. In total, 15 facilities and three acute-care units have active outbreaks

- 44 Emergency Weather Response shelters, 934 beds, have been converted to Capacity Extension Shelters until end of June across province
- Provincial Isolation Sites as of 2020May20: 84 sites; 2685 spaces
  - Vancouver Coastal: 15 sites, 885 spaces
  - Fraser Region: 15 sites, 430 spaces
